Alessandro Minichilli è Professore Ordinario presso il Dipartimento di Management e Tecnologia dell'Università Bocconi. Presso SDA Bocconi è Associate Dean for Faculty, Direttore del Corporate Governance Lab, e co-Direttore dell'eSG Lab - excellence in Sustainability e Governance per le PMI. In precedenza è stato Faculty Deputy del Knowledge Group di Strategy, Entrepreneurship and Governance, nonché Direttore Ricerca nell'ambito della Divisione "Claudio Dematté" Corporate and Financial Institutions.

La sua collaborazione con SDA è iniziata nel 2004. Da allora ha tenuto diversi corsi su Corporate Governance e Family Business sia in Master (MBA, GEMBA, MCF), sia in numerosi corsi Executive. In particolare, è direttore o co-direttore dei corsi executive SDA Bocconi Directors' Program, International Board Program, Governance Program, General Management PMI – Medie imprese, Family Strategies e pianificazione patrimoniale. È inoltre coordinatore scientifico del programma SDA Bocconi - Elite (Borsa Italiana), nonché direttore delle iniziative di Board induction per società quotate e non.
