

**SPONSOR FUNDED TUITION WAIVERS
FOR MSM CANDIDATES**

Selected sponsors of the MSM at SDA Bocconi are making available **3 partial merit-based tuition waivers up to € 15,000** to 2026/27 MSM candidates with an outstanding profile.

1. Beneficiaries and Requirements

The tuition waiver is available to students with an outstanding profile and they should meet the following requirements:

- They meet all admissions requirements for the participation in the **2026/27 MSM Program**.

Only candidates who have submitted application within the deadline, producing all required documentation and have been admitted to the **2026/27 MSM Program** are eligible for tuition waivers.

2. Incompatibility and Loss of Tuition Waivers

The waiver can be combined with any other scholarship, award, or financial support for specialization courses by public or private organizations or companies if the total amount does not exceed the total registration fee. The beneficiary must self-certify that the above-mentioned accumulation has not been exceeded. A candidate may not cumulatively receive more than one tuition waiver awarded by SDA Bocconi or by sponsors of MSM SDA Bocconi.

The beneficiary must comply with these conditions for the whole duration of the MSM Program.

The right to the tuition waiver is subject to the regular completion of the **2026/27 MSM program** as indicated in the **2026/27 MSM Rules**.

3. Lodging of Applications and Results

Applications for the tuition waiver must be sent through the [online application portal](#) in accordance with the deadlines indicated in the table below. The assignment of the tuition waiver will be formally notified to the beneficiary by the Commission through an assignment letter, no later than the Communication of assignment dates indicated in the table below.

Tuition Waivers Application Time Frames and Communication of Results:

	Application for the Tuition Waivers	Communication of the assignment
1st round	Deadline: 23/04/2026	Within 28/05/2026
2nd round	Deadline: 08/07/2026	Within 24/09/2026
3rd round	Deadline: 28/10/2026	Within the MSM Program's beginning

Applications will be evaluated according to the following criteria: analysis of academic and professional record, analysis of the requirements indicated above, results of the MSM selection process. The number of assignments to applicants will not be equally divided amongst the different rounds. The final percentage of awarding for each round is at the discretion of the Commission and their decision is final and unquestionable. A limited number of applicants, at the discretion of the Commission, who were not assigned a tuition waiver during their round may be placed on a waiting list and be reconsidered in the following round. The amount of the tuition waiver assigned, up to **€ 15,000**, is at the discretion of the Commission and their decision is final and unquestionable.

4. Acceptance of the conditions

Application for the tuition waiver involves full acceptance of the herein conditions. Under penalty of immediate withdrawal, the candidates must confirm their enrolment in the **2026/27 MSM** as well as formalize their acceptance of all tuition waiver conditions with the Admissions office by the deadline indicated on the tuition waiver assignment letter.
