

TUITION WAIVER FOR OUTSTANDING EMILUX CANDIDATES

SDA Bocconi School of Management is making available four partial merit-based tuition waivers up to EUR **11.500** to 2027/28 EMILUX candidates with an outstanding profile.

1. Beneficiaries and Requirements

Tuition waiver is available only to students with superior academic achievements, proven professional acumen, a determination to influence the future of business and meeting the following requirements:

- An outstanding personal, academic and professional CV with significant interest in luxury field.
- They have not received any financial support, if combined with the SDA Bocconi tuition waiver, in excess of the total tuition fee (scholarships or sponsorships).
- They meet all admissions requirements for the participation in the 2027/28 EMILUX Program.

Only candidates who applied within the deadlines, producing all required documentation and have been admitted to the 2027/28 EMILUX Program, are eligible for tuition waiver.

2. Incompatibility and Assignment of Tuition Waiver

The tuition waiver is not compatible with the Early Bird Fee.

The admitted candidate who completes his/her formal enrollment by September 15th, 2026 will receive the Early Bird Fee. He/she will still be eligible for the partial Tuition Waiver. In case he/she will be elected for the partial Tuition Waiver, the Early Bird Fee will be replaced by the partial Tuition Waiver fee and the payment guidelines will be updated.

The waiver can be combined with any other scholarship, award, or financial support for specialization courses by public or private organizations or companies if the total amount does not exceed the total registration fee. The beneficiary must self-certify that the above-mentioned accumulation has not been exceeded. The beneficiary must comply with this condition for the whole duration of the EMILUX Program.

The right to the tuition waiver is subject to the regular completion of the EMILUX Program as indicated in the 2027/28 EMILUX Rules.

3. Lodging of Applications and Results

Applications for the tuition waiver, together with a Motivational Letter, must be sent through the online Application portal in accordance with the deadlines indicated in the table below.

Tuition Waivers Application Time Frames and Communication of Results:

1st round	Deadline: 16/6/2026	Within 16/7/2026
2nd round	Deadline: 26/11/2026	Within the EMILUX Program's beginning

Applications will be evaluated according to the following criteria: analysis of academic and professional records, analysis of the requirements indicated above, and results of the EMILUX selection process. The number of assignments to applicants will not be equally divided amongst the different rounds.

The final percentage of awarding each round is at the discretion of the Commission, and their decision is final and unquestionable. A limited number of applicants, at the discretion of the Commission, who were not assigned a tuition waiver during their round may be placed on a waiting list and be reconsidered in the following rounds. The amount of the tuition waiver assigned, up to €1.500, is at the discretion of the Commission, and their decision is final and unquestionable.

4. Acceptance of the conditions

Application for the tuition waiver involves full acceptance of the herein conditions. Under penalty of immediate withdrawal, the candidate must confirm his/her enrolment in the 2027/28 EMILUX as well as formalize his/her acceptance of all tuition waiver conditions with the Admissions office by the deadline indicated on the tuition waiver assignment letter.
